Reason for EOL:

In 2007 Atmel has decided to discontinue its GPS business without developing successor products.

Since 2011 Atmel GPS solutions are phased out by our customers leading to an ongoing decrease of Atmel's GPS business. This decrease will further gain momentum through 2012/13 reducing actual run-rates drastically and requiring coordinated exit procedure.

Further, in support of Telefunken Semiconductor GmbH (TSG) wafer start requests that significantly exceed current run rates, Atmel is pulling forward future wafer demand on those existing Atmel products which are exclusively manufactured by TSG. In order to ensure that Atmel does not purchase wafers in excess of certain Customer demands Atmel is issuing EOL notices to align life time demand.

As the wafer start rates currently exceed demand, Atmel has shortened the last time by period to enable us to quickly assess and build the correct mix of products and thus mitigate risk.

Consequently, Atmel sets all its automotive GPS products end of life.

Atmel kindly requests that last time buy orders be placed by 30 September 2012.
